



**REPLY TO EXPLANATION-A01044/09-28-01/2023 DATED SEPTEMBER
28, 2023**

Dear Ar. Irfan Tariq,

1. I feel extremely disappointed to read the Explanation Letter whereby I have been directed to reply to accusations of false and dishonest declarations in my CV levied against me by some junior Architect, Syed Muhammad Jalal Haider PCATP No. A-06997 (the "**Complainant**").
2. Without prejudice, there are certain technical objections to the Explanation Letter which I would like to raise as follows:
 - a. The **Complainant has no locus standi**, being neither an employee of COMSATS, nor a colleague, student or alumnus. There appears to be no apparent reason for his Complaint other than being used as a proxy for political rivals within PCATP. Therefore, the Complaint is not maintainable.
 - b. The **Explanation Letter has not been issued by the Competent Authority**, which under the PCATP Byelaws is the Registrar; however, the Explanation Letter has been issued in violation of the Byelaws by someone who is an 'Acting Registrar' – an office not provided for in the PCATP Ordinance or the Byelaws thereunder.
 - c. An 'Acting Registrar', being non-tenured, is serving at the whims of the incumbent Chairman; therefore, the 'Acting Registrar' is urged to act within the PCATP Byelaws, restrict his activities and refrain from issuing illegal letters.
 - d. The Explanation Letter is palpably smacking of malafides and has been issued as a tool for personal score setting; to discourage questions about the current crisis of the PCATP. It does not in any manner upholds higher academic standards nor helps to improve the PCATP's standing in educational institutions.
3. I strongly question the Complainant's source of information; he has alleged inaccuracies about my input in national and international projects, at a time when he might not even have been born (1987-1988). Clause 92 of the PCATP Byelaws places the burden of proof on the Complainant, who makes factual

claims against an individual; the complainant instead of providing conclusive proof (which of course is not there) is violating the PCATP code of conduct by putting the onus on PCATP to find the facts – the Complainant has failed to provide the proof of his slanderous claims and hence, has breached the Code of Professional Conduct (the “Code”).

4. Moreover, it is ridiculous for my employer to be answerable to PCATP in its official affairs, as it is not bound to provide any explanation or document to PCATP with respect to its internal decisions. PCATP has no authority to question my employer (Comsats University), with whom I have served with honor and dedication for 16 years at the positions of HoD, Chairperson and Dean and the details of my CV and all supporting testimonials of the various positions held by me (prior to joining COMSATS in 2007) were examined at the time of my initial appointment. The applicability of the Code is untenable in light of my employer’s satisfaction with my work ethics.
5. I am a foreign qualified PhD (out of two) in architecture in the twin cities, I have been a valuable resource and a teacher for years, I am insulted at the allegations that my actions have been a loss for public sector. I have read the Code in detail; however, I am unable to find language to the effect of PCATP having the authority of handling claims of loss to the public sector. I have served as a respected member of the PCATP Executive Committee for 2 terms and have provided my academic expertise to the council. I am currently a member of the IAP National Council. All of these positions were through national elections and my success in them demonstrates the respect and good will of my peers.
6. The Complaint is incomplete, irrelevant and highly biased. The Complainant has gone to extreme lengths to exaggerate and quote inaccurate data, no doubt in pursuance of a bigger vendetta against me, possibly due to my constructive criticism to improve the current working of PCATP.
7. It is clear to all that The Complaint seems to be part of a bigger conspiracy against my good name and the Complainant is being used as a pawn. Therefore, I demand a transparent inquiry for such disgraceful conduct under the Code so that the Complainant and his accomplices are exposed and held accountable for intending to harm the reputation of a senior member of PCATP. I also demand revocation of license of the Complainant by PCTAP for showing such careless disregard towards a senior and respected member of the profession by spreading his factitious allegations to other unrelated organizations.
8. That, on 2nd October 2023, Mr. Hammad Hussain (currently removed from PCATP; updated on October 4th 2023. Annex a) shared a copy of the PCATP-Explanantion-A01044/09-28-01/2023, (issued to me on 28th September 2023) with various faculty members of COMSATS among others. The fact that this

confidential information was shared/leaked deliberately by the 'Acting Registrar' with a non- member of the PCATP (before the 7 day notice period to me ended) in order to defame me and harass me is in gross violation of the Rule 2.0 of PCATP Code of Professional Conduct and liable for action under Section 29 of PCATP Ordinance IX of 1983. This misconduct from the esteemed office of the Registrar is a breach of the trust of the whole membership of the PCATP, it has never happened during the tenure of the earlier Registrars and must be condemned.

9. I reserve the right to proceed against the persons who are working together (within PCATP and other non-members) to defame me and to cause anguish to the many architects who admire me and hold me as a role model.

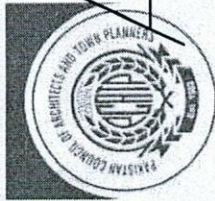

Dear Sir,

With reference to your Explanation Letter, dated 30.04.2023, and upon the instructions of our Client, M/s. Usama Hassan & Amina Soomro, Co-Founders of "The Design Loft" (hereinafter referred to as "**Our Client**"), we hereby address you as under:

1. That, as a matter of background, Our Client is a well-recognized Architecture and Interior Designing Firm, distinguished for its reliability and known for its quality of work. Since its inception, Our Client has undertaken prestigious projects and erected notable structures, thereby attaining considerable success and rapid expansion within a short span of time.
2. That all the contentions raised and allegations levied by Ar. Mishaal Rozina Merchant against Our Client were also previously communicated by her to Our Client through WhatsApp Messages/Email, dated 22.03.2024, which culminated into the Notice, dated 24.03.2024, wherein she purportedly threatened Our Client of coercive action in lieu of the violation of the Code of Professional Conduct established by the Pakistan Council of Architects and Town Planners (hereinafter referred to as "**PCATP**") in relation to the ongoing project located at Plot No. 126/II & 126/I, Khayaban-e-Ghalib, Phase VIII-A, D.H.A., Karachi (hereinafter referred to as "**Project**"). Whereinafter, Our Client had promptly responded to her baseless allegations vide the Reply Letter, dated 26.03.2024, and refuted all her claims.

*(Copy of the WhatsApp Messages/Email, dated 22.03.2024: Copy of the Notice, dated 24.03.2024: Copy of the Reply Letter, dated 26.03.2024, are attached herewith as "**Exhibit A**")*

3. That all the contentions and allegations made by Ar. Mishaal Rozina Merchant against Our Client are denied in total. It is pertinent to note that:
 - a. That as per Rule 3.3. of the Code of Professional Conduct of PCATP, an architect or town planner shall not attempt to supplant another architect or town planner. In consideration of

the same, it is humbly submitted that Our Client has not supplanted Ar. Mishaal Rozina Merchant in relation to the Project in question. It is apt to mention that her allegations are unfounded, as she has failed to provide any evidence regarding the same and has merely made this instance complaint due to professional jealousy.

- b. That as per Rule 3.4. of the Code of Professional Conduct of PCATP, an architect or town planner on approached or instructed to proceed with work upon which he knows, or can ascertain by reasonable inquiry, that another architect or town planner is or has been engaged by the same client shall notify the fact to such architect or town planner prior to undertaking the assignment. In consideration of the same, it is to be noted that upon being engaged for the Project Our Client had executed a Formal Engagement Letter, dated 19.04.2024, with the Clients, Salim Sher Ali and Sasha Salim (hereinafter referred to as "Clients"). Wherein, Our Client had not only made reasonable inquiry as to whether another architect or town planner is engaged on the Project but also the Clients had given a signed undertaking that no other consultant, architect, or interior designer was currently working or engaged on the Project for which the services of Our Client were being attained.

That as per Rule 3.4. of the Code of Professional Conduct of PCATP, it was the responsibility of Our Client to notify Ar. Mishaal Rozina Merchant only in the circumstances where upon reasonable enquiry Our Client could have ascertained that she was engaged for the Project. It is to be noted that such an enquiry was not only undertaken but also the Clients had given a signed undertaking that no architect was engaged on the Project when the services of Our Client were being attained. Therefore, the obligation under Rule 3.4. of the Code of Professional Conduct of PCATP has been complied in full and has not been violated by Our Client.

(Copy of the Executed Formal Engagement Letter, dated 19.04.2024, is attached herewith as "Exhibit B")

- c. That as per Rule 3.6. of the Code of Professional Conduct of PCATP, an architect or town planner shall not sign or put his signature to drawings, plans, or specifications, not prepared by him or by his staff working under his supervision for the purpose of obtaining the sanction of any building authority. In consideration of the same, it is pertinent to highlight that Rule 3.6. of the Code of Professional Conduct of PCATP is not only very specific in nature and only concerns for the purpose of obtaining a sanction from any building authority but also the allegations levied by Ar. Mishaal Rozina Merchant that the original drawings and design created by her were edited and presented by Our Client are baseless and unfounded as neither her allegations fall under the purview of this instant rule nor she has provided any evidence regarding the same.
- d. That, notably, as per Rule 1.1. of the Code of Professional Conduct of PCATP, an architect or town planner in private practice shall inform his client in advance of the Conditions of Engagement and the scale of charges and agree with his client that those Conditions shall be the basis of his appointment and shall not accept any other payment or consideration for the duties entrusted to him. In consideration of the same, Ar. Mishaal Rozina Merchant was not only under an obligation to sign an engagement letter and/or a contract with the alleged

Clients as per the instant rule but also before contending that Our Client has supplanted her Project and was under an obligation to notify her, she first needs to establish that she was initially engaged as an architect and/or consultant for the Project by the Clients, which she has miserably failed to do so. Hence, all of the allegations levied by her are not only baseless/unfounded but also lack the relevant foundation as required under Rule 1.1. of the Code of Professional Conduct of PCATP.

4. That in light of the above-mentioned, we kindly request the Honorable Forum to dismiss the Complaint filed by Ar. Mishaal Rozina Merchant against Our Client, as it is based on unfounded and unsubstantiated claims lacking any verbal and/or documentary evidence. It is to be noted that this instant Complaint is not only based on unfounded/unsubstantiated claims but also the mere purpose of the Complaint is to misuse the law and to gratify her personal ego which not only demonstrates professional jealousy but also undermines the development/growth of young and promising architects/town planners.
