PAKISTAN COUNCIL OF ARCHITECTS AND TOWN PLANNERS (ORDINANCE IX OF 1983)

PCATP/01-08-02/2024 Dated: August 01, 2024

Dear PCATP Members,

Further to notice for AGM dated: 3<sup>rd</sup> August, 2024, it is to inform all registered members that AGM 2024 will be completely held virtually under PCATP byelaws, Clause 7 (a);

"The Annual General Meeting of the Council shall be held simultaneously at Karachi, Lahore, Islamabad, Quetta and Peshawar through any available electronic means, such as video conferencing, skype meeting, etc. However, the Chairman shall preside the meeting at the Head Office of the Council.
